Community College Info

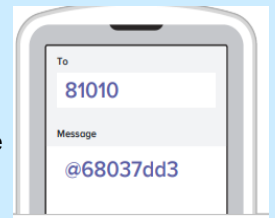
If you are planning on attending Sierra College in the fall, their online application became available October 1, 2018. If your plans are to attend Folsom Lake College/EI Dorado Center, their application became available online November 1, 2018.

Whichever community college you choose, make sure to complete the five step process AS SOON AS POSSIBLE to ensure you receive priority registration.

- Step 1: Application
- Step 2: Assessment
- Step 3: Orientation
- Step 4: Counseling
- Step 5: Registration

TO DO LIST

- * Check your college app "to do" lists and watch deadlines. Send transcripts ONLY if the school requests them.
- * December is the last chance to take the SAT/ACT tests and still meet most colleges admissions deadlines.
- * Winter break is coming, why not spend some of that time working on scholarship applications? For **local scholarships** create your profile at www.CALocalScholarships.org. Don't forget to request your letters of recommendation. Make sure to look at the requirements for each scholarship for which you are applying. If you have everything ready, your applications will be easy to complete and submit by the March 1, 2019 deadline. I am available to give you individual help just about everyday during lunch, 6th & 7th periods, and after school.
- * Check out the "Scholarships for the Week" posted on the College & Career Center page of the school website under the College Information link.
- * Register for a FSA ID (for you and your parent) so you can complete and sign the Free Application for Federal Student Aid (FAFSA) online at: <http://fsaid.ed.gov>. **Apply for FAFSA between Oct 1, 2018—Mar 2, 2019.**

Don't catch SENIORITIS!

You will be receiving acceptance letters from the colleges you applied to within the next month or two. This does not give you a green light to SLACK. Remember a college can just as easily send you a letter of withdrawal if you do not keep your grades up or if you begin to catch Senioritis!

ALSO, any significant changes made to your schedule for the spring semester need to be reported to the colleges to which you applied.

FUNDING YOUR EDUCATION

Frequently asked questions:

How might the Federal Student Aid help pay for schooling?

- ◇ Federal student aid includes grants, work-studies and loans. You do not have to pay back grants. Work study allows you to earn money for your education, and loans allow you to borrow money for school.

When can I apply?

- ◇ For 2019-2020, you should apply online at www.fafsa.ed.gov as early as October 1, 2018 but BEFORE March 2, 2019.

What will I need to get started?

- ◇ You will need your FSA ID (federal student aid ID number) and your valid Social Security number to apply for federal student aid. Your eligibility will be determined by your parents' financial information.

What kind of information does the financial aid application (FAFSA) ask?

- ◇ FAFSA (Free Application for Federal Student Aid) will ask for information from your **parents'/guardians'** 2017 U.S. income tax return. If you, the student, filed a return, that information will also be needed.

How will I know what I am eligible for?

- ◇ Once your FAFSA is processed, a formula is applied to the information that you provided. Congress established this formula to determine your financial need. The formula result is the Expected Family Contribution (EFC). The EFC indicates how much money you and your family will be expected to contribute toward the cost of attendance for the 2019-2020 school year.

Calculating your family contribution.

- ◇ For dependent students the following facts are considered in calculating your EFC: Your income and your parents income; you and your parents' assets, including savings, stocks & bonds, real estate investments, business ownership and trusts, but the primary residence equity is excluded; your parents' age and need for retirement income; the number of children in the household; and the number of children attending college.

Are there deadlines that I must meet?

- ◇ Yes. You should pay special attention to the many deadlines involved in the student financial aid process. Missing a deadline could prevent you from receiving the aid for which you are eligible. The Federal/State student aid programs must receive the FAFSA by **March 2, 2019**.
